Robust OCR capabilities automatically identify image files, trigger the embedded OCR engine, and extracts text making the files searchable. Deliver processed discovery data in native format or as tiff images with enhanced endorsing and bates numbering.

Now users can process all types of files creating a Group or Groups of data that can be easily searched for information that matters most to your client. Dynamic Views are created early in the project and remain active for its duration. Create Views in DC Console (user interface) or DC Detective; searching and tagging across an entire collection has never been so easy! Working from one View spanning multiple Groups saves time and greatly reduces the complexity of data delivery.
